- If a candidate wishes to submit election advertisements in a hard copy format for public inspection, he/she must provide the relevant Returning Officer with 2 copies of each election advertisement concerned together with a copy of the information sheet, consent of support and/or permission for display of election advertisements or conduct of electioneering activities at private premises within 1 working day (i.e. any day other than a general holiday and Saturday) after publication of any election advertisements. In respect of the election advertisements which cannot be practically or conveniently produced in specie, 2 identical full colour photographs/printouts/photocopies of each election advertisement together with 1 copy of the information sheet, consent of support and/or permission for display of election advertisements or conduct of electioneering activities at private premises must be provided. The candidate must ensure that the election advertisement particulars provided comply with the rules and requirements as set out in section 108 of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap 541I), and Chapter 8 of the "Guidelines on Election-related Activities in respect of the Election Committee Subsector Elections".
