- at the start of the interview, make known to the electors the name of the person or organisation conducting the exit poll and that the exit poll is not commissioned by the Government;
- > not to collect or retain any personal data (such as name and Hong Kong Identity Card number) relating to the identity of the electors;
- > not to stay, loiter or accost electors in the areas designated as the No Staying Zone;
- > not to speak to or otherwise communicate with candidates or their agents when conducting the poll outside polling station(s); and
- not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 13 of the Guidelines).

Such a list will also be displayed at the respective polling stations. All the identity document numbers and the declarants' addresses will be covered up before the lists are displayed.

(b) Transfer of Information

The personal data and other related information supplied in connection with this Application Form may be provided to other authorised departments or persons, including but not limited to the courts for election-related purposes.

(c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Personal Data Protection Principles

Please note that applicants must observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this Application Form, in particular Principle 4 concerning the requirement to take

all practicable steps to ensure that the personal data are protected against unauthorised or accidental access, processing and use.

(e) Enquiry
