Under section 3(2) of the Particulars Relating to Candidates on Ballot Papers (Legislative Council and District Councils) Regulation (Cap. 541M), a candidate may request the Electoral Affairs Commission to print a personal photograph of the candidate and the particulars set out in any one of the following paragraphs, with or without the particulars specified in item 4 of the Schedule to the said Regulation (“Schedule”) –

- (a) the particulars specified in item 1 or item 2 or both of the Schedule and relating to not more than 3 prescribed bodies;
- (b) the particulars specified in item 3 of the Schedule and relating to the candidate; or
- (c) the particulars specified in item 1 or item 2 or both of the Schedule and relating to not more than 2 prescribed bodies, and the particulars specified in item 3 of the Schedule and relating to the candidate.

Schedule

1. Either or both of the following –
 - (a) the registered Chinese name or the registered abbreviation of the Chinese name (but not both) of a prescribed body;
 - (b) the registered English name or the registered abbreviation of the English name (but not both) of a prescribed body.
2. The registered emblem of a prescribed body.
3. The registered emblem of a prescribed person.
4. The words “獨立候選人 Independent Candidate” or the words “無黨派候選人 Non-affiliated Candidate” (but not both).
5. **附錄**只用作指示列印於選票上的詳情的位置，並不合乎實際比例。
The **Annex** is only used to indicate the position of the particulars to be printed on a ballot paper and it is not to scale.

Drawings cannot be transcribed to the Braille templates and Braille name lists which are provided to voters with visual impairment for vote marking on ballot papers on their own. If a requestor requests to print on a ballot paper the registered emblem of a prescribed body, but not including its registered Chinese/English name or registered abbreviation of the Chinese/English name, the registered abbreviation of the Chinese and/or English name of the concerned prescribed body will be transcribed to the Braille name lists so as to provide voters with visual impairment with the relevant particulars. If there is no registered abbreviation of the Chinese and/or English name of the concerned prescribed body, its registered Chinese and/or English name will be transcribed to the Braille name lists. If a requestor requests to print on a ballot paper the registered emblem of a prescribed person relating to the candidate, such particulars will not be transcribed to the Braille templates and Braille name lists.
8. 提交的彩色照片必須顯示候選人臉部的正面及不大於 50 x 40毫米 (2 x 1 5/8 英吋)。照片背景必須無任何裝飾，顏色為白色、淺藍色或淺粉紅色，請勿採用螢光色或漸變色作背景。照片須為最近6個月內所拍攝。為達到較佳的印刷效果，請選用沖晒相紙，並避免以噴墨式或鐳射打印機印出照片。選舉管理委員會保留調整照片影像的權利。
The colour photograph to be submitted must show the full face of the candidate and must not be larger than 50 x 40 mm (2 x 1 5/8 inches) in size. The photograph must have a plain background in the colour of white, light blue or light pink. Please do not use fluorescent or gradient colour as the background. The photograph should be taken within the last six months. For better printing quality, please use photofinishing paper. Photo printing by inkjet or laser printer should be avoided. The Electoral Affairs Commission reserves the right to adjust the image on the photograph.

If the particulars requested by the requestor to be printed on a ballot paper include the particulars of one or more prescribed bodies, the consent of the relevant prescribed bodies for the particulars to be printed on a ballot paper in relation to the request made by the candidate should also be submitted together to the Returning Officer before the end of the relevant period.

The personal data and other related information provided in this form will be used by the Electoral Affairs Commission, the Registration and Electoral Office, other authorised departments or persons, and can be disclosed, for purposes relating to the Particulars Relating to Candidates on Ballot Papers (Legislative Council and District Councils) Regulation (Cap. 541M) and for online public inspection after compilation. The information to be made available for online public inspection will not include the Hong Kong identity card number, correspondence address, telephone number, personal photograph and signature of the candidate concerned.

(b) Transfer of Information

The information in this form may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Enquiry

Enquiries concerning the personal data collected by means of this form, including the making of requests for access and corrections, should be addressed to the Chief Electoral Officer at 10th Floor, Harbour Centre, 25 Harbour Road, Wanchai, Hong Kong.
