The Hong Kong Special Administrative Region shall be a local administrative region of the People's Republic of China, which shall enjoy a high degree of autonomy and come directly under the Central People's Government.

# 填寫 2019 年區議會一般選舉確認書說明 Notes on Completion of Confirmation Form for the 2019 District Council Ordinary Election

1. 本確認書旨在確保候選人在簽署提名表格內的有關聲明時,已清楚明白《基本法》的 內容以及作出有關聲明的法例要求和相關責任。

This confirmation form aims to ensure that a candidate clearly understands the contents of the Basic Law and the legal requirements and responsibilities concerned in making the relevant declaration in the nomination form.

2. 選舉主任可按《選舉管理委員會(選舉程序)(區議會)規例》(第 541F章)第 12(10) 條要求獲提名的候選人提供其認為適當的任何其他資料,以令其信納候選人有資格獲 提名或該項提名是有效的。

According to section 12(10) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), the Returning Officer may require a candidate to furnish any other information that he/she considers appropriate to satisfy himself/herself as to the eligibility of the candidate or the validity of the nomination.

3. 候選人在提交提名表格時,請同時把由候選人簽妥的確認書送交有關選區的選舉主任。如未能在提交提名表格時同時遞交確認書,候選人應於遞交提名表格後的**兩天內** (但不遲於 2019 年 10 月 17 日下午五時)藉專人送遞、電子郵件或圖文傳真方式將已簽妥的確認書送交選舉主任,以便選舉主任可盡早處理有關的提名。

Candidate is reminded to submit a confirmation form duly signed by the candidate together with the nomination form to the Returning Officer for the relevant constituency. If the confirmation form cannot be submitted at the time when the nomination form is submitted, the candidate should submit the duly signed confirmation form to the Returning Officer by hand, by electronic mail or by facsimile transmission within **two calendar days** after the nomination form has been submitted (but not later than 5 p.m. on 17 October 2019) to the Returning Officer to facilitate early processing of the nomination.
