

Notice for Collection of Electors' Information
2012 Legislative Council Election - Functional Constituencies
(Other than the District Council (second) Functional Constituency)

After submission of nomination form, candidate may request:

- (1) a set of "Candidate Mailing Label System" DVD and its User Guide; and/or
- (2) a set of mailing labels of registered electors (**excluding electors who have provided their e-mail address, except those in custody of Correctional Services Department**) (size of each label is 102mm (L) x 36mm (W)).

To avoid wastage of resources, candidate should carefully consider his/her publicity plan before requesting the above item(s). Upon confirmation of the item(s) requested, please return the completed reply slip of "Notice for Collection of Electors' Information" with the "Undertaking on the Use of Electors' Information" (see attached) to the Returning Officer.

Upon receipt of the duly completed reply slip and undertaking, the requested item(s) will be available for collection in 5 working days at the respective Returning Officer's office.

Environmentally-friendly Promotion

To protect environment and reduce the consumption of paper and other resources, you are encouraged to send the election promotional materials to electors in the following ways as far as possible:

- Please carefully consider your publicity plan and the quantity of mails before requesting the mailing labels;
- Please use joint election mails for promotion (For Labour Functional Constituency ("FC") only)(This can reduce half of mailing labels and mails if two candidates in Labour FC send out joint election mails for promotion); and
- Please use the information in the "Candidate Mailing Label System" to send election advertisements to electors who have provided their e-mail address.
