- 根據《立法會條例》(第 542 章)第 19(2)條，每個地方選區須選出的議員人數不得少於五名，亦不得多於九名。  
In accordance with section 19(2) of the Legislative Council Ordinance (Cap 542), the number of Members to be returned for each GC is to be a number, not less than five nor greater than nine.
- 由於新界西已獲分配《立法會條例》就一個地方選區可得的議席數目所容許的上限(即九個)，餘下兩個議席只可分配予其他四個地方選區。分配議席的方案共有六個。  
Since New Territories West has been allocated the maximum number of seats for a GC (i.e. nine) as permitted under the statutory requirement of the Legislative Council Ordinance, the two remaining seats can only be allocated to other four GCs. There are six options for allocation.

在這六種方案中，方案 E 所得的個別地方選區人口與其所得數目偏離百分比的幅度最小，即在個別地方選區之間，由一個立法會議席所代表的人口數字的差異最小，因此，餘下兩個議席會分配予九龍西和新界東。

Among the six options, Option E has the smallest range of percentage deviation of the population from the resulting number in the individual GCs, i.e. the variations between individual GCs in terms of the number of persons represented by a Legislative Council seat is reduced to a minimum. Accordingly, the remaining two seats are allocated to Kowloon West and New Territories East.

Resulting number is obtained by multiplying the number of seats allocated to the GC and the population quota (i.e. 210,586).
