 I understand that to uphold the Basic Law means to uphold the Basic Law including the following provisions:

第一條 Article 1

香港特別行政區是中華人民共和國不可分離的部分。

The Hong Kong Special Administrative Region is an inalienable part of the People's Republic of China.

第十二條 Article 12

香港特別行政區是中華人民共和國的一個享有高度自治權的地方行政區域,直轄於中央 人民政府。

The Hong Kong Special Administrative Region shall be a local administrative region of the People's Republic of China, which shall enjoy a high degree of autonomy and come directly under the Central People's Government.

第一百五十九(四)條 Article 159(4)

本法的任何修改,均不得同中華人民共和國對香港既定的基本方針政策相抵觸。

No amendment to this Law shall contravene the established basic policies of the People's Republic of China regarding Hong Kong.

3. 我明白根據《選舉管理委員會(選舉程序)(立法會)規例》(第 541D 章)第 103 條,任何人在與選舉有關的文件中作出他明知在要項上屬虛假的陳述,或任何人罔顧後 果地在該等文件中作出在要項上不正確的陳述,或任何人明知而在該等文件中遺漏任何 要項,均屬犯罪。我亦明白此確認書會連同提名表格供公眾查閱。

I understand that in accordance with section 103 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), a person who, in an election related

document, makes a statement which that person knows to be false in a material particular or recklessly makes a statement which is incorrect in a material particular or knowingly omits a material particular from an election related document commits an offence. I also understand that this confirmation form will be made available for public inspection together with the nomination form.

Notes on Completion of Confirmation Form for the 2018 Legislative Council By-election

1. 本確認書旨在確保候選人在簽署提名表格內的有關聲明時,已清楚明白《基本法》的 內容以及作出有關聲明的法例要求和相關責任。

This confirmation form aims to ensure that a candidate clearly understands the contents of the Basic Law and the legal requirements and responsibilities concerned in making the relevant declaration in the nomination form.

- 2. 選舉主任可按《選舉管理委員會(選舉程序)(立法會)規例》(第 541D 章)第10(10) 或第 11(11)條要求獲提名的候選人提供其認為適當的任何其他資料,以令其信納候選 人有資格獲提名或該項提名是有效的。
 - According to sections 10(10) or 11(11) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the Returning Officer may require a candidate to furnish any other information that he/she considers appropriate to satisfy himself/herself as to the eligibility of the candidate or the validity of the nomination.

Candidate is reminded to submit a confirmation form duly signed by the candidate together with the nomination form to the relevant Returning Officer. If the confirmation form cannot be submitted at the time when the nomination form is submitted, the candidate should submit the duly signed confirmation form to the Returning Officer by hand, by electronic mail or by facsimile transmission within **two calendar days** after the nomination form has been submitted (but not later than 5 p.m. on 29 January 2018) to the Returning Officer to facilitate early processing of the nomination.
