^{Note 2} According to section 75(7)(a)(ii) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap 541D) (“EAC (EP) (LC) Reg”), any ballot paper, which appears to be not marked in accordance with section 55(2), i.e. the chop is not affixed to give a single “√” in the circle opposite the candidate of the elector’s choice, is questionable, and it should be up to the RO or PRO to decide whether the vote is to be counted. When making the decision, if the RO or PRO believes the ballot paper is not marked with the chop provided at the polling station, the vote is not to be counted pursuant to section 80(1)(ha).
