^{Note 2} Referring to a deceased or disqualified candidate.

^{Note 3} According to section 77(7)(a)(ii) of the EAC(EP)(LC) Reg, any ballot paper which appears to be not marked in accordance with section 57(2), i.e. the chop is not affixed to give a single "✓" in the circle opposite the names of the candidates of the elector's or authorised representative's choice, is questionable, and it should be up to the RO to decide whether the vote is to be counted. When making decision, if the RO believes the ballot paper is not marked with the chop provided at the polling station, the vote is not to be counted pursuant to section 80(1)(hb).
